
# 2023-2024 Respiratory Disease

#### A Weekly Influenza Surveillance Report Prepared by the Influenza Division

Outpatient Respiratory Illness Activity Map Determined by Data Reported to ILINet

This system monitors visits for respiratory illness that includes fever plus a cough or sore throat, also referred to as i.i., not laboratory confirmed influenza and may capture patient visits due to other respiratory pathogens that cause similar symptoms.
